

History of NDOT / Funding

- 1916 Federal Aid Road Act of 1916 For construction of new highways (50/50)
- 1917 State Legislature created the Nevada Department of Highways.
 - Three-member Highway Board members appointed by Governor
- 1921 Amendment to Federal Road Act of 1916 50/50 to 87/13

- Created the Forest Hwy. Program

- 1923 First NV State Fuel Tax Enacted
- 1927 Hwy. Board Change Governor, Attorney General & State Controller
- 1933 National Industrial Recovery Act of 1933 Allowed Federal Funding of "Emergency" Highway Projects
- 1934 Hayden-Cartwright Road Act of 1934 Federal Funding for Urban Highway Projects
- 1940 Amendment to State Constitution Protecting the State Highway Fund
- 1944 Federal Aid Highway Act of 1944 Improving Farm to Market Roads, Repair Caused by Military Vehicles
- 1954 Federal Aid Highway Act of 1954 Substantially Increased Federal Funding to NV
- 1956 Federal Interstate System Federal Funding to Build the National Highway Network
- 1956 Highway Revenue Act Established the Highway Trust Fund






History of NDOT / Funding (Cont'd)


- 1965 Highway Beautification Act of 1965 Federal Funding to Control Billboards and Junkyards
- 1966 Highway Safety Act of 1966 Federal Funding Focused on Highway Safety
- 1979 Department of Highways became the Nevada Dept. of Transportation
- 1982 Surface Transportation Assistance Act (STAA) of 1982 Fuel Tax Increase (1st since 1959)
- 1984 Deficit Reduction Act of 1984 Fuel Tax Increase
- 1989 Transp. Board Change Seven-Member Board (Gov., Cont., A.G., Lt. Gov., 3-At-large)
- 1987 Surface Transportation and Uniform Relocation Assistance Act of 1987 Speed Limit 65MPH
- 1990 Omnibus Budget Reconciliation Act of 1990 (OBRA 90) Fuel Tax Increase
- 1991 Intermodal Surface Transportation & Efficiency Act Planning and Intermodal Focus
- 1993 Omnibus Budget Reconciliation Act of 1993 (OBRA 93) Last Federal Fuel Tax Increase
- 1998 Transportation Equity Act for the 21st Century
- 2005 Safe, Accountable, Flexible, Efficient Transportation Equity Act Regional Transp. Plans
- 2012 MAP-21 Focus on Performance Measures

Gasoline Tax Per Gallon








State Special Fuel Tax






State Highway Fund Disbursements State Fiscal Year 2014



HIGHWAY TRUST FUND HEADWINDS: GAS TAX HAS LOST ITS PURCHASING POWER




Fuel Revenue Indexing (FRI)

- Fuel Revenue Indexing adjusts the revenues from fuel sales to the rate of inflation, which allows continued development, enhancement and rehabilitation of our infrastructure.
- In 2009 the State Legislature allowed Washoe County to index its fuel revenue indefinitely, and in 2013 the State Legislature allowed Clark County to index its fuel revenue through 2016.
- FRI dollars are helping fund NDOT projects in Clark County with the Interstate 11 Boulder City Bypass Phase 1 starting in 2015. Without FRI funding, Phase 1 was scheduled for 2018 and Phase 2 was unfunded. US 95 widening improvements are also being funded with FRI dollars.
- RTC Washoe used FRI funding for the Southeast Connector, which will relieve I-580 traffic and free up other federal funds for joint projects.



Electric/Hybrid Vehicles and VMT

- Electric vehicle ownership has been increasing since 1999. It increased 108% nationwide from 2011 to 2013.
- Average fuel economy has increased from 24 MPG in 1982 to 34.9 MPG in 2014. It is required to go up to 54.5 MPG by 2025. This has led to decreased per capita fuel consumption and increased vehicle-miles-traveled.
- In Nevada, between 2007 and 2013, VMT increased from 12.6 billion VMT to 23.5 billion VMT, while highway revenue declined from \$297,141,989 in FY 2007 to \$266,878,866 in FY 2014.
